Local Control Accountability Plan (LCAP) Update #1 11/27/18

Welcome and Introductions

Dr. Crean welcomed members of the LCAP Central Committee to the first meeting of the school year. He offered a special welcome to the new members joining the committee. Following self-introductions by the members, Dr. Crean introduced Mrs. Maya and explained her role in guiding the LCAP committee through the process.

Review of LCAP Requirements

Mrs. Maya, consultant, shared a PowerPoint presentation titled "LCAP Update 2019-2020." In this presentation, Mrs. Maya talked about the history of the plans, stating that in the past they were written as three year rolling plans whereas now the LCAP is a three year inclusive plan (2017-2020). Mrs. Maya stated that the upcoming plan is the last plan of three year cycle. Mrs. Maya stated that the goal of this committee is to review the current plan and conduct a yearly update that will lead to the 2019-2020 LCAP Plan.

Review Goals/Action/Services

Mrs. Maya reviewed copies of the 2017-2018 data reports. These reports include a summary of 2017-2018 LCAP goals attainment as measured by Smarter Balanced Assessment results, English learner language proficiency results, parent satisfaction rates, chronic absenteeism, middle school dropout rates, attendance, suspensions and expulsions. Mrs. Maya also reviewed ELA SBAC scores comparing 2016-2017 results with 2017-2018 results, Math SBAC scores comparing 2016-2017 results with 2017-2018 results, ELA and Math CAASPP scores comparing LLCSD results with State, County and surrounding area district results and 2017 ELPAC results.

Mrs. Maya then asked each table to look at the "Review of Performance" for Goal 1 (Student Achievement), Goal 3 (Stakeholder Engagement) and Goal 4 (School Climate), focusing the table discussion on Greatest Progress/How to maintain or build on success, and Greatest Need/Next steps to improve for each of the three goals. Input from each of the tables was shared and recorded.

Mrs. Maya then directed the group's attention to the Metrics/Action/Services that outline how each goal is measured and the Actions and Services that are in place to meet the Goal. Each group was asked to read and review the Goal Metrics/Actions and Services for goals 1-4. Each group was then asked to: (1) come to consensus on the Metrics/Actions and Services and (2) grant permission to keep or tweak the Metrics/Actions and Services, providing the necessary language needed to tweak any area. Upon completion of this activity each group gave consensus on the Goal Metrics/Actions and Services for goals 1-4.

Next Steps

Mrs. Maya highlighted the next steps of the LCAP Central Committee to be taken at the next meeting on Wednesday, February 6, 2019.
